





Background

Abu Dhabi National Oil Company (ADNOC) is planning the development of a major oil and gas field in Abu Dhabi. The Hail and Ghasha Development has been divided into several packages. Package 2 focuses on building the Ghasha offshore gas processing plant.

Oct 2021	The contractors have submitted the technical bids for the FEED works on the project.			
Sep 2021	Worley, Flour, and Technip Energies are constructing their technical bids for the revised FEED tender while KBR and Wood have declined to participate. The submission has been moved to October 4, 2021.			
Aug 2021	The revised FEED tender has been announced. The submission deadline for the technical bids is September 23, 2021.			
Jul 2021	Kent has finally acquired SNC-Lavalin after 5 months of negotiation.			
Jul 2021	The oil and gas engineering firms have been issued notifications for a new tender for the Pre-Feed and Feed works for the Hail and Ghasha Development.			
May 2021	The EPC award date is yet to be finalized as ADNOC is carrying out an internal discussion on the FID (Final Investment Decision) of the project.

Feb 2021	ADNOC has postponed the commercial bids submission to February 24, 2021.
Jan 2021	The submission of the commercial bids has been extended until 17th February 2021.
Jan 2021	The deadline for the submission of commercial bids for the EPC contract has been extended until 24 January 2021.
Dec 2020	The shortlisted bidders are: -Petrofac & Samsung -Hyundai -Archirodon & Sinopec -Saipem, National Petroleum Construction Company (NPCC) & China Petroleum Engineering & Construction Corporation (CPECC)
Dec 2020	The commercial bids submission for the main contract has been postponed until 10 January 2021.
Oct 2020	ADNOC has extended the submission of the commercial bids till 6th of December 2020 and the scope is being revised for the EPC contract.
Sep 2020	The series of virtual meetings have been undertaken by ADNOC where each bidding contractor has been allotted a day to discuss the scope of work and the capabilities of contractors in light of the adverse impact due to the COVID-19 outbreak.
Sep 2020	ADNOC is yet to finalize the submission dates of the commercial bids.
Jul 2020	The submission date for the commercial bids has now been set for November 2020.
May 2020	The deadline for bids submission has been delayed until 31st July 2020.
Apr 2020	The submission of the bids has been set for 31st May 2020.
Mar 2020	The commercial bids submission deadline has been further extended until 22nd April 2020.
Mar 2020	The bidders are preparing to submit the commercial bids on 29th March 2020.
Feb 2020	ADNOC is carrying out technical clarification meetings with the bidders for the main contract.

Dec 2018	ADNOC awarded OMV with 5 per cent stake in the Ghasha offshore gas concession.
Oct 2018	EPC bids are currently under review. The contract shall be awarded at the end of January 2019.
Jul 2018	ADNOC has extended the deadline to 26 August 2019 for the contract bids to reclaim a series of offshore islands for the development of its Hail and Ghasha sour gas fields.
Jun 2018	Feed is still undertaken and these contractors submitted EOI for C,D and E: Archirodon Dredging International Hyundai Engineering & Construction Jan De Nul NMDC Royal Boskalis Westminster Six Construct Van Oord
Feb 2018	FEED is being carried out at the moment.
Jan 2018	Fugro has been selected to undertake geophysical and geotechnical surveys and has just started these works for the project.
Jan 2018	The team is not allocated yet at Bechtel. The company is waiting to receive a go-ahead and a plan from the UK head office.
Jan 2018	The FEED contract has been awarded to Bechtel. It is expected to be completed by Q4 2019.
Dec 2017	Companies have submitted bids for the front end engineering design (FEED) contract from: Technip Flour Corporation Bechtel Worley Parsons
Oct 2017	Some further discussions and planning are taking place before any further movement.
Aug 2017	Planning is still taking place, FEED announcement is yet to happen.
Jul 2017	KBR has been officially awarded the PMC contract. It is also understood that the FEED enquiry hasn't been out yet.
Jun 2017	KBR is expected to win the PMC deal for the sour gas reservoirs. The tendering process is overseen by OMV. The FEED contract is still under bidding stage since the process has been pushed back to a later date.
Jan 2017	FEED contract still requires allocation and there's no news regarding this progress at this moment.
Jun 2016	The FEED contract is yet to be announced.
Mar 2016	Pre-qualification of companies to carry out the FEED has been announced.
Feb 2015	OXY has been appointed with a \$500 million four-year contract for exploration and development of the field. The contract includes 3D seismic surveys, drilling of appraisal wells and conducting of engineering studies necessary for the fields' development.

The project's scope of work will include:

- Facilities to be installed on the project's artificial islands
- Ghasha offshore processing plant
- Central living quarters

Project Finance

Abu Dhabi National Oil Company (ADNOC) is the project client. It is 60% owned by ADNOC and 40% owned by Occidental Petroleum (OXY).

The Ghasha ultra-sour gas concession comprises of the Hail, Ghasha, Dalma, Nasr, Sarb, Bu Haseer, Shuweihat, and Mubarraz offshore sour gas fields. The stakeholders of the concession are:

- ADNOC 55%
- Eni 25%
- Wintershall Dea 10%
- OMV 5%
- Lukoil 5%

ADNOC has signed the PMC framework agreement with 3 engineering firms for the Ghasha concession and has been awarded to KBR, SNC Lavalin, and TechnipFMC. The firms will share a 50:30:20 percent ratio, with KBR as the lead project management firm followed by SNC Lavalin and Technip FMC. PMC services will be provided for all the packages of the Hail and Ghasha Development project.
